

#### 2022 DUES AND FEES STRUCTURE FOR NEW MEMBERS

**PRIMARY MEMBERSHIP** – You will be remitting your Local (GSAR), State (CAR) and National (NAR) dues to the Glenwood Springs Association of REALTORS®.

- 1. Application Fee - \$300.00 new member application fee.
- 2. Dues – Total for 2022 is \$660.00 which is pro-rated monthly. Please verify the correct amount prior to submitting payment.
- 3. MLS Fee - \$50.00 per month per user, billed to the office monthly. Sharing your username and password is against the Aspen/Glenwood MLS rules and regulations. Anyone found in violation of this rule will be fined \$1000.00.

### MEMBERSHIP REQUIREMENTS

\*Association Orientation is held in the Association classroom from 9:00 a.m. to 12:00 noon. You will be notified when the next class is scheduled.

\* The 2.5 hour New Member Ethics Course offered for FREE on the NAR website: https://www.nar.realtor/coeeduc.nsf/findnrdsrecord?openform (Please note: If an NAR Ethics course has been completed within the last year at another Association/Board, include verification and this requirement may be waived.)

You have 6 months in which to complete these two classes. If you have not done so in this time period, you must reapply and your application will be processed as a new application. The Principal Broker of your firm will then be assessed the dues in accordance with the Association's Bylaws.

SECONDARY MEMBERSHIP - For a secondary membership (which means your State and National dues are remitted through another association/board), only the Glenwood Springs (Local) portion is due on a pro-rated basis, plus the \$300.00 application fee per member.

**NEW OFFICE** - If you are a Designated REALTOR® and want to join our Association there is a non-refundable new office set-up fee of \$1000.00. The new office fee for a branch office with the same DR/SDR is \$500.00.

Thank you for your inquiry regarding membership. Please submit fees and dues with your completed application form; we accept checks (made out to GSAR), Visa, MasterCard, Discover or American Express. Please expect two business days for processing.

I understand that I will be required to complete periodic Code of Ethics training as specified in the association's bylaws as a continued condition of membership.

**NOTE:** Applicant acknowledges that if accepted as a member and he/she subsequently resigns from the association or otherwise causes membership to terminate with an ethics complaint pending, the Board of Directors may condition renewal of membership upon applicant's certification that he/she will submit to the pending ethics proceeding and will abide by the decision of the hearing panel. If applicant resigns or otherwise causes membership to terminate, the duty to submit to arbitration continues in effect even after membership lapses or is terminated, provided the dispute arose while applicant was a REALTOR®.
