Child Care Ballot Measure Approved. Garfield County has approved an effort by the Confluence Early Childhood Development Service District to seek voter approval of a 0.25 percent sales tax to help support childcare services in Garfield and Pitkin counties, as well as the portion of Eagle County, which lies in the Roaring Fork School District. If passed by voters, the service district would be created to help provide financial support for both families seeking early childhood development programs, and providers of services, such as day care and preschool, from Parachute to Aspen. The proposed measure will likely go before voters either later this year or in 2026. The Board of County Commissioners approved the amended service plan unanimously, 3-0. While Garfield County approved the measure, CECE must now obtain approval from Eagle and Pitkin counties.

HB 25-1040 Nuclear Energy Added to Definition of Clearn Energy Resources Passes Legislature. An effort that has been years in the making to add nuclear energy as an option to meet the state's renewable goals is finally on the way to the Governor's desk after the Legislature approved the measure in late March. To be clear, the bill does not green light any nuclear construction projects but it does clear the way for nuclear projects to receive local grants that have previously been earmarked for solar, wind and geothermal projects. There has been considerable interest in the possibility of generating nuclear power in Northwest Colorado. Mike Solomon, project manager for the Associated Governments of Northwest Colorado's Northwest Colorado Energy Imitative has noted that group is taking an all of the above approach in assessing our need for energy in the future. Construction Defects Legislation Passes First Legislative Hurdle. HB-1272 passed out of the State Library, Transportation, Housing and Local Government Committee on a 12-1 vote and cleared second reading in the House on March 28th. The Colorado Association of Realtors supports this bill and is leading the effort for its passage. H.B. 25-1272 would create a new, voluntary framework under C.R.S. § 13-20-803.3: the Multifamily Construction Incentive Program. Projects built under this program would be governed by a separate set of litigation rules, designed to reduce construction defect claims, and encourage builder participation in the entry-level housing market.
